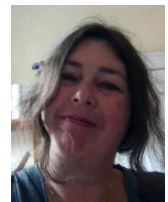
A special event for owners of Listed Properties, combining talks from leading experts, a guided visit to Lewes Castle, lunch & refreshments

Directions and Parking

From the East or West : follow the A27. Take the turning to Lewes (marked 'Lewes and Tunbridge Wells'). At the exit of the Cuilfail Tunnel, turn left, go straight over the mini-roundabout and bear left at the traffic lights. Parking is available in the public car park immediately after Waitrose on your left or in several other public car parks nearby. We are to be found at the foot of the High Street on the right, look for the portico and red door
From London : Take the M23 and then the A23 until you reach the A27. Take the Eastbound A27 and follow the directions above. Other : Lewes can also be reached from Haywards Heath (via A275) and from Uckfield (via A26). Lewes has a mainline railway station with a taxi rank directly outside. To walk from the station to our office takes approximately seven minutes. The journey time from London Victoria is approximately 1 hour. Nearby bus stops are at Lewes Bus Station and Waitrose - for buses to and from Brighton and surrounds.

Accessibility

This event at Adams & Remers is held at our ground-floor meeting rooms and toilets are available on both the ground and first floors. The afternoon visit to Lewes Castle will require a short uphill walk (10 minutes). Comfortable walking shoes are recommended. Lewes Castle welcomes all visitors however, due to the nature of the historic site, wheelchair access is limited to the lower levels. Accessible toilets are available in the Education Resource Centre.
