If you are obtaining funding from a bank to assist with the purchase, we can liaise with your funders to help with any specific requirements they may have.

Our advice to any buyer is to plan your purchase carefully. Identifying and dealing with issues before the purchase completes is far more preferable than trying to resolve these after the event, which will invariably cost considerable time and money.

If you are proposing to sell a pharmacy, we can advise on the steps to be taken to prepare the business for sale which will help to streamline the process.

We can also advise on the different ways of structuring a sale and guide you through the various ways a buyer will attempt to deal with the risks involved in acquiring the business.

Planning is an essential stage of any sale – time spent getting your pharmacy ready for sale will be time well spent. It is far better to spend time resolving any issues before negotiations commence with a potential purchaser than to do this ‘on the fly’.


