At Milford Roundabout take A286 via Haslemere and Midhurst. Before Chichester on leaving Singleton village take left turn over the Downs past Goodwood Racecourse then follow brown tourist board signs for Goodwood House (approx 4 miles).

#### From Southampton and Brighton

Take A27 to Chichester. Follow brown tourist board signs to Goodwood House.
